Subscription to Front Desk is annual. The _____ fee is \$_____ a household for the first year. Subscription fees will be paid annually in advance or monthly by VISA. The subscription begins on the first day of the month in which payment is made, and will continue for the next twelve consecutive months.

As a Front Desk Subscriber, you may contract directly with and be billed for services and products by third-party providers who are independent contractors. It is your obligation to timely pay the provider for those goods and services you request. One of Florence Front Desk's primary functions is to ensure your highest possible satisfaction with the services and products provided. However, Front Desk will not assume any direct or indirect responsibility or liability in connection with goods or services by third party providers whom Front Desk recommends.

Agreements.

1. In order for Front Desk to monitor my needs and levels of satisfaction, I authorize third-party providers to share non-medical data with Florence Front Desk about the services I use. I also authorize Front Desk to communicate with my personal contacts in case of situations of health or safety concerns.

2. I agree that Front Desk may terminate this agreement at any time for any reason with 30 days' notice to me in writing. In the event of termination before the annual subscription is fully utilized, I understand that any part of the subscription paid for in advance but not used, will be refunded to me within 60 days.

AS A FRONT DESK SUBSCRIBER, I/WE UNDERSTAND AND ACKNOWLEDGE THAT ANY GOODS OR SERVICES I/WE MAY REQUEST ARE PROVIDED BY INDEPENDENT CONTRACTORS WHO ARE NEITHER AGENTS OR EMPLOYEES OF FRONT DESK, INC. AND I/WE HEREBY AGREE TO RELEASE AND FOREVER HOLD HARMLESS FRONT DESK, INC. FROM ANY AND ALL CLAIMS I/WE MAY HAVE AGAINST ANY SAID INDEPENDENT CONTRACTOR, INCLUDING BUT NOT LIMITED TO, CLAIMS BROUGHT ON MY/OUR BEHALF BY MY/OUR INSURANCE CARRIER, OR ANY OTHER ENTITY, FOR DAMAGES, COSTS, AND/OR ATTORNEY'S FEES.

I/WE ALSO ACKNOWLEDGE AND STATE THAT I/WE WERE GIVEN THE OPPORTUNITY TO CONSULT WITH LEGAL COUNSEL BEFORE SIGNING THIS SUBSCRIPTION AGREEMENT.
